This particular White Paper's primary focus is on the brave men and women who are in the trenches each and every day as law enforcement officers fighting on behalf of the children. It is as dreadful and pervasive as any terminal disease known to mankind. The effects are exactly the same *as a terminal disease* – including death.

Allow me to begin a point by clearly stating: "If you think law enforcement are doing nothing – You Would Be Dead Wrong." I spent a great deal of time speaking with the FBI "Agent" about the issue of child pornography and learned a great deal about the work he and his team do.

Above all of the methods put in place to protect our children, I also saw the true face of law enforcement – both that of the "Officer" and the "Agent." These are good men (and women; however for the purpose of this paper I had only dealt with two men – but I know for a fact there are women in law enforcement who are just as brave and effective).
